| | 3.1 Trust Board Members reported that the comprehensive Annual Report read well and showcased the successes of the Academy. Members confirmed that the Annual Report articulated the Academy's educational and social achievements for pupils. The excellent sporting accomplishments detailed in the report were highlighted. Appreciations were extended to those who had contributed to the report. | | | |
| | 3.2 With regards to the review of accounts, governors were advised that a different format was introduced to meet the new requirements for charity accountability. The Academy's Auditors had concluded a good audit outcome and this was a credit to those responsible for financial management at the Academy. Although a deficit was predicted for 2015-16, a year end surplus was reported. Trust Board Members confirmed that the start of 2016-17 the Academy had a cumulative surplus of £500k and this would support deficits expected over the next 2-3 years during the transition to a secondary school. The surplus had allowed for improvements to the fabric of the school and further works were planned for April 2017. The effective recruitment, retention and reduction in sickness incidence of staff was noted as a key element of the budget, as this was the biggest expenditure. Members concluded that the financial accounts showed as good a picture as to be expected. | | | |
| | 3.3 In relation to SATS, despite the disappointing results for Pupil Premium and most-able students, overall the results were good and the Principal was aware of the areas that required improvement. | | | |
