Cambridge National Health and Social Care is split into three units. Two are compulsory and one is optional (chosen by the school).

What will my child gain from Health and Social Care?

The Cambridge National in Health and Social Care will encourage students to:

- understand and apply the fundamental principles and concepts of the rights of individuals, person centred values, effective communication and how to protect individuals in health and social care settings
- develop learning and practical skills that can be applied to real-life contexts and work situations
- think creatively, innovatively, analytically, logically and critically
- develop independence and confidence in using skills that would be relevant to the health and social care sector and more widely

Where will Health and Social Care take my child?

Learners who generally achieve at Level 2 across their key stage 4 learning might consider progression to:

- A Levels as preparation for entry into higher education in a range of subjects
- study of a vocational qualification at Level 3, such as a BTEC National in Health and Social Care, which prepares them to enter employment or apprenticeships, or to move on to higher education by studying a degree in aspects of health or social care.
