IMPORTANT INFORMATION:
Diphtheria, Tetanus, Polio (DTP) and Meningococcal ACWY (MenACWY)

In line with the National Immunisation Programme, the Community School Aged Immunisation Service offers Diphtheria, Tetanus and Polio and Meningococcal ACWY vaccinations to all pupils in Year 9. It may also be offered to anyone who missed the vaccinations in year 10 and above.

Diphtheria, Tetanus and Polio booster

This booster dose is important to ensure a young person's continuing immunity and protection against these diseases.

Meningococcal ACWY

Meningococcal ACWY vaccination helps to protect your child against 4 types of meningococcal bacteria (groups A, C, W and Y) that can cause meningitis (inflammation of the lining of the brain) and septicaemia (blood poisoning). Cases of meningococcal W disease in England have increased significantly in recent years. Universities, Colleges and future employers increasingly ask for evidence of this vaccination.

Consent Form

It is important for you to discuss and complete the consent form with your child. Please be aware that if we do not receive the completed electronic consent form, each young person will be assessed on an individual basis in line with the Gillick Competency Framework. They may be invited to self-consent for the above vaccinations, providing they can demonstrate an understanding of the vaccinations due. Ultimately, the decision to consent or refuse is the young person's providing they understand the issues involved in giving consent.

Measles / Mumps / Rubella (MMR)

We would also like to remind you that all children and young people should have 2 doses of MMR. If you are not sure whether your child has been fully immunised against MMR please contact your GP or Practice Nurse for advice.
