The impact of domestic abuse

In association with Refuge, the UK Trauma Council has summarised the findings of 10 research projects about the impact of domestic abuse on children and young people.

The report rounds up the potential trauma resulting from domestic abuse, including the wide range of social, emotional and psychological challenges for children and young people, plus the factors that can help to mitigate harm.

Talking about child sexual abuse

The CSA Centre has published a new edition of their guidance, 'Communicating with Children' which provides parents and professionals with the knowledge and confidence to talk with children about sexual abuse.

This edition provides new guidance for professionals about how to support children with a variety of different communication needs. It aims to help professionals enable more children to communicate about what has happened to them, in a way that works best for them.

The Online Safety Act

Changes to the Online Safety Act are intended to create a safer online environment for all users.

Additional protections for children

The act now includes firmer expectations on social media platforms to protect children from viewing harmful content. Platforms are legally bound to act swiftly to block and remove illegal content/material.

Enhanced adult controls

Adults will have more control over the content they see online. The act now requires platforms to provide clear options for users to manage their exposure to potentially harmful content.

Accountability and transparency

Social media companies are required to provide greater transparency about the content on their platforms.

Ofcom's expanded role

Ofcom, the independent regulator, has been given broad powers to enforce compliance with the new safety framework. Ofcom's role includes risk assessments, publishing codes of practice and guidance, as well as enforcing regulations to ensure platforms conform to the new standards.

Phased implementation

Ofcom is taking a phased approach to implementing the provisions of the act. This includes publishing codes of practice and guidance in three phases: illegal harms duties, child safety duties, and transparency/user empowerment duties.
