Financially motivated sexual extortion

The criminal practice of extorting individuals after coercing them to provide self-explicit material is commonly known as 'sextortion'. The practice's technical name 'Financially Motivated Sexual Extortion' or FMSE, is an increasingly prevalent form of online child sexual abuse. What started as simple money exchanges, now include cryptocurrency seizures and pre-paid gift cards as forms of criminal redemption.

Males aged 14 to 17 are overwhelmingly represented in cases of this nature. Often, they will be enticed by the promise of seeing sexually explicit images, before the rug is pulled and the scam put into operation. As a result, the victims have been tricked or groomed over a period of time. With the rise of AI, this practice is becoming more complex with false explicit images actually changing hands, in exchange for a real image of the target. No doubt children all over the country are now looking forward to celebrating Christmas this year and receiving gifts of all kinds. However, not all gifts are created equally.

Now more than ever our Christmas shopping is done online from a frequently varied list of sellers. This may include imitation manufacturers, sellers' platforms like Etsy and third-party small businesses that use known provider logistics services. We are trusting people from all corners of the globe to manufacture and deliver our Christmas goods to the standards of production that we are used to when buying goods in the UK.

Unfortunately, this is far from guaranteed. Production firms abroad or within a 'cottage industry' may not have the strict manufacturing standards applied in the UK, or expected as industry standard. When children and young people experience traumatic or difficult life events, their emotional world can be shaken, and the impact may show up in their behaviour, mood or relationships. Whether it is bereavement, a family breakdown or witnessing something distressing, the support of trusted adults can be key in helping them feel safe again. This guide looks at how to create a nurturing environment to help young people process difficult feelings.

It also shares clear, actionable strategies to promote recovery, from building emotional literacy and creating a predictable routine to recognising signs that further help may be needed. Sensitive language, patience and presence all play a part in empowering children to move forward at their own pace. With the right support, they can rebuild a sense of security and resilience.
